

BUILDER—OPEN

Scope of work

- (1) Building work on all classes of buildings.
- (2) Prepare plans and specifications if the plans and specifications are—
 - (a) for the licensee's personal use; or
 - (b) for use in building work to be performed by the licensee personally.
- (3) However, the scope of work does not include—
 - (a) a completed building inspection for an interested party; or
 - (b) personally carrying out any building work for which—
 - (i) a fire protection licence is required; or
 - (ii) an occupational licence is required unless the licensee holds the occupational licence
- (4) *interested party,* for a building, means a party or prospective party to a contract of sale for the building.

Technical qualifications for Contractor's or Nominee Supervisor's licenceAny 1 of the following—

- (a) successful completion of Advanced Diploma of Building and Construction (Management) CPC60208;
- (b) successful completion of a course the commission considers is at least its equivalent to the course mentioned in paragraph (a);
- (c) a recognition certificate as a qualified builder to carry out the scope of work for the licence class;
- (d) a qualification or statement of attainment of required competency for the class of licence.

Technical qualifications for Site Supervisor's licence

Any 1 of the following—

- (a) the technical qualifications for contractor's licence, as above;
- (b) successful completion of the following units of competency—
 - (i) Apply building codes and standards to the construction process for large building projects CPCCBC6001A;
 - (ii) Manage processes for and legal obligations of a building or construction contract CPCCBC6004A;
 - Apply structural principles to the construction of large, high rise and complex buildings CPCCBC6014A;
 - (ii) Assess construction faults in large building projects CPCCBC6016A;
- (c) successful completion of a course or units of competency of a course the commission considers is at least equivalent to a course mentioned in paragraph (b).

Experience requirements

The experience requirements are the following—

(a) for a person who has a technical qualification mentioned in one of the following licence

classes:

- Bricklaying and Blocklaying
- Carpentry

- -2 years experience in-
 - (i) the scope of work for the class; or
 - (ii) other work the commission is satisfied is at least equivalent to experience in the scope of work for the class;
- (b) otherwise—4 years experience in—
 - (i) the scope of work for the class; or
 - (ii) other work the commission is satisfied is at least equivalent to experience in the scope of work for the class.

Classification Summary of Buildings and Structures defined in the Building Code of Australia 2005

CLASSES O	F BUILDING	y or Bananigo and Cauciarco domica in the Bananig Codo or Additional 2000		
Class 1	Class 1a A single dwelling being a detached house, or one or more attached dwellings, each a building, separated by a <i>fire-resisting</i> wall, including a row house, terrace house, house or villa unit.			
	Class 1b	A boarding house, guest house, hostel or the like with a total area of all floors not exceeding 300m2, and where not more than 12 reside, and is not located above or below another dwelling or another Class of building other than a private garage.		
Class 2	A building containing 2 or more sole-occupancy units each being a separate dwelling.			
Class 3	A residential building, other than a Class 1 or 2 building, which is a common place of long term or transient living for a number of unrelated persons. Example: boarding-house, hostel, backpackers accommodation or residential part of a hotel, motel, school or detention centre.			
Class 4	A dwelling in a building that is Class 5, 6, 7, 8 or 9 if it is the only dwelling in the building.			
Class 5	An office building used for professional or commercial purposes, excluding buildings of Class 6, 7, 8 or 9.			
Class 6		A shop or other building for the sale of goods by retail or the supply of services direct to the public. Example: café, restaurant, kiosk, hairdressers, showroom or service station.		
Class 7	Class 7a Class 7b	A building which is a carpark A building which is for storage or display of goods or produce for sale by wholesale.		
Class 8	A laboratory, or a building in which a handicraft or process for the production, assembling, altering, repairing, packing, finishing, or cleaning of goods or produce is carried on for trade, sale or gain.			
Class 9		a public nature.		
	Class 9a	A health care building, including those parts of the building set aside as a laboratory.		
	Class 9b	An assembly building, including a trade workshop, laboratory or the like, in a primary or secondary school, but excluding any other parts of the building that are of another class.		
	Class 9c	An aged care building.		
Class 10		ble building or structure.		
	Class 10a	A private garage, carport, shed or the like.		
	Class 10b	A structure being a fence, mast, antenna, retaining or free standing wall, swimming pool or the like.
